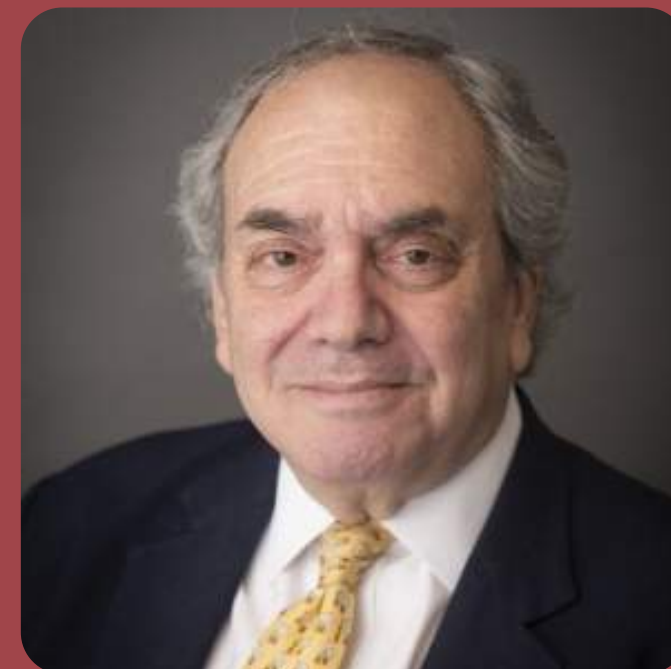

## COMMENTS FROM THE FORUM REPORTER

*Settlements are the typical outcome of successful mediation procedures, a major focus of the Dispute Resolution Institute which we are planning to establish shortly as a separate and independent entity in Geneva. One may ask why settlements may cause difficulties when it comes to their enforcement. The parties have agreed about the resolution of their dispute, and there should be no further impediment to completing the process. In practice, reality is often different. Being satisfied about the compromise achieved, the parties should think about the completion of the settlement process.*

*The worst situation for the party having a claim is to have to sue in the courts of the debtor's country to enforce its rights. In this regard, the pandemic has caused additional difficulties when seeking judicial assistance. In this Forum, our experts will discuss how enforcement should be addressed as early as the stage of drafting the settlement agreement. Furthermore, enforcement tools available at the level of domestic laws will be discussed. Attention will also be given to specific trade usages in certain sectors. Most importantly are the international conventions, the most prominent of which being the Singapore Convention on mediation and its prospects to be accepted on an international level.*
